

MINUTES OF THE WIRT COUNTY BOARD OF EDUCATION

September 14, 2010

The Wirt County Board of Education met in their regular session on Tuesday, September 14, 2010, in the Wirt County High School cafeteria. Present were James Rader, President, Jerry Ash, Vice President, Carl Brainard, Mark Lowe, and Chuck Mills, members, Daniel Metz, Superintendent, and Karen Cummings, Treasurer.

Mr. Rader called the meeting to order at 6:30 p.m. On a motion by Mr. Ash, seconded by Mr. Lowe, the minutes of the previous meeting held on August 24, 2010, were approved.

Mrs. Angela Smith addressed the Board regarding Wirt County Schools' Attendance Policy.

Mrs. Diane Ludwig presented the Board a check for \$10,000 from the Parkersburg Area Community Foundation. This grant is to help fund the Primary Center/Middle School walking trail.

On a motion by Mr. Mills, seconded by Mr. Ash, the Board approved payment of invoices totaling \$159,409.50, budget supplements totaling (\$54.00) and budget transfers totaling \$58,088.83.

On a motion by Mr. Mills, seconded by Mr. Ash, the Board approved volunteers/chaperones as recommended by the Superintendent.

On a motion by Mr. Lowe, seconded by Mr. Mills, the Board approved Glenville State College student Jason Fox and WVU-P students Jackie Bunch, Michele Simmons, Kelly Roberts, & Felicia Thompson to fulfill student placement requirements in Wirt County Schools.

On a motion by Mr. Ash, seconded by Mr. Mills, the Board entered into an executive session at 7:15 to review the Superintendent's Goals for 2010-2011. The Board returned to regular session at 7:30 on a motion by Mr. Brainard, seconded by Mr. Mills. On a motion by Mr. Lowe, seconded by Mr. Mills, the Board approved the Superintendent's Goals for the 2010-2011 school year.
