

MINUTES OF THE WIRT COUNTY BOARD OF EDUCATION

January 11, 2011

The members of the Wirt County Board of Education met in their regular session on Tuesday, January 11, 2011, in the Wirt County High School cafeteria. Present were James Rader, President, Jerry Ash, Vice President, Carl Brainard, Mark Lowe, and Chuck Mills, Members, Dan Metz, Superintendent, and Karen Cummings, Treasurer.

Mr. Rader called the meeting to order at 6:30 p.m. On a motion by Mr. Ash, seconded by Mr. Lowe, the minutes of the previous meeting held on December 21, 2010, were approved.

The Board entered into an executive session at 6:33 p.m. to conduct a student discipline hearing. The motion to enter into executive session was made by Mr. Mills, seconded by Mr. Brainard. The meeting returned to regular session at 6:50 p.m. on a motion by Mr. Mills, seconded by Mr. Lowe. On a motion by Mr. Ash, seconded by Mr. Brainard, the Board voted to expel a Wirt County High School student as a dangerous student for 365 days.

On a motion by Mr. Mills, seconded by Mr. Lowe, payment of invoices totaling \$197,178.61 was approved.

On a motion by Mr. Brainard, seconded by Mr. Ash the following personnel actions were approved:
