

MINUTES OF THE WIRT COUNTY BOARD OF EDUCATION

June 14, 2011

The Wirt County Board of Education met in their regular session on Tuesday, June 14, 2011, in the Wirt County High School cafeteria. Present were James Rader, President, Jerry Ash, Vice President, Carl Brainard, Mark Lowe, and Chuck Mills, members, Daniel Metz, Superintendent, and Karen Cummings, Treasurer.

Mr. Rader called the meeting to order at 6:30 p.m. On a motion by Mr. Ash, seconded by Mr. Lowe, the minutes of the previous meeting held on May 24, 2011, were approved.

At 6:37, on a motion by Mr. Mills, seconded by Mr. Ash, the Board voted to enter into an executive session to conduct a personnel hearing. The meeting returned to regular session at 7:40 p.m. on a motion by Mr. Mills, seconded by Mr. Ash. On a motion by Mr. Ash, seconded by Mr. Mills, the Superintendent's recommendation of a 30-day suspension without pay, of a Christine Wilson, Wirt Primary teacher, was upheld by the Board. On a motion by Mr. Ash, seconded by Mr. Mills, the Board approved the Superintendent's recommendation of the suspension of ~~the same~~ Christine Wilson, Wirt Primary Center, teacher indefinitely, without pay, until the conclusion of legal charges[1].

On a motion by Mr. Lowe, seconded by Mr. Brainard, the Board approved payment of invoices totaling \$215,728.29, and budget transfers totaling \$50,153.85.

On a motion by Mr. Ash, seconded by Mr. Mills, the Board accepted the resignations of Jamey Murray, Teacher and FFA Advisor at Wirt County High School, and Courtney Burns as Assistant Girls' Basketball Coach at Wirt Middle.
